INDEMNITY:

FINANCIAL AGREEMENT:

The information captured on this form is regarded as true and correct. By giving any false information on this form, this application will become null and void. The completion and submission of the application form does not guarantee admission in Laerskool Nelspruit.

The application form must be completed in full and all relevant documents must be attached. This is a legal and binding document. No areas must be left open or crossed out. No tippex is allowed. School fees for 2023 amount to R19,400 per child per annum.

School fees for 2024 are only determined at the annual budget meeting that will be held in October. School fees are calculated pro-rata and is payable in 10 equal payments. The first installment is payable at the start of the learner's first day of school, thereafter on or before the 7th day of each month. Failure to pay school fees or abide by the installment agreement is considered a breach of contract and full school fees will become due and payable. School fees are charged in accordance with the SA Schools Act 84 of 1996. The necessary legal action with costs, as determined between attorney and client will be instituted and it will be handed over for collection.

NELLIE MIERE: ADMISSION CRITERIA


1. Re-registration of currently enrolled learners of Laerskool Nelspruit Nellie Miere.
2. Preference will be given to brothers and sisters of children already enrolled at Laerskool Nelspruit.
3. Preference will be given to children who permanently reside with their parents within the feeder area of the school and whose mother tongue is Afrikaans or English.
4. Learners whose parents are permanently employed within the natural feeding area of Laerskool Nelspruit and whose mother tongue is Afrikaans or English.
5. Learners permanently residing with their biological parents as prescribed by the SASA within the natural feeding area of Laerskool Nelspruit. The chosen medium of instruction must either be Afrikaans or English as indicated on the application form.
6. Learners whose parents are permanently employed at an institution or business within the natural feeding area of Laerskool Nelspruit and the chosen medium of instruction is Afrikaans or English as indicated on the application form.
7. Learners who reside outside the natural feeding area of Laerskool Nelspruit whose mother tongue or chosen medium of teaching is Afrikaans or English, with the understanding that the application be accepted on merit and not on a first come first served basis.
8. The SGB will notify the parent in writing, without a statement of reasons, if the application is successful or unsuccessful.

DECLARATION BY THE UNDERSIGNED:

1. The Governing Body / Principal has informed me how much the compulsory yearly school fees are per learner.
2. The Governing Body / Principal has informed me that I am obliged to pay school fees in advance before the 7th day of the month.

Consent form in terms of the protection of personal information Act 4 of 2013 (POPIA)
